BHA released the formal request for interest in Soar IV. It is a grant resource for the AF Whitsitt Center crisis beds and also supports our safe station initiatives, and other projects as well as our harm reduction activities.

MDH and BHA with leadership at KCHD put in a formal request for expansion of services in the old Carter Center space, for the development of crisis beds for our youth population. We are looking at an 8 bed unit that would serve both young men and women ages 10 to 17 for a crisis level stabilization service.
