• Fundraising Planning/Updates

- Maryland Health Connections would like to set up a table with information. The board has approved with no charge since they are not selling any items.

Director's Report:

- **The Divisional Performance Report** FIA and Child Support continue to have issues collecting accurate numbers of stats. 10 children in foster care and 9 adult guardianship.
- **Staffing Update** Joyce is retiring after 36 years of service. Tina will be acting Assistant Director until recruitment. Jen will fill in and help with Human Resources. Two new Child Support Trainee's begin April 5th. New Services Case Worker Rachel West. 2 other vacancies to be filled in Services.
- SNAP/EBT Fraud Maryland is the first State to implement a plan to assist customers who have been affected from loss of benefits due to fraudulent activity. Over 2300 customers in Maryland (25 in Kent) have lost benefits. Customers can have their benefits replaced up to two times per year. The Office of Inspector General performs the investigation and handles the prosecution of reported cases among Maryland. SNAP and EBT are administered through a third party vendor.
- **District 36 Event** Shelly attended an event in Annapolis on March 13th to partner with State Senators and Delegates. Directors and affiliates were able to answer benefits questions and walkin through the House and Senate to watch a bill being passed.
- **Kent DSS Outreach** DSS have signed up to be a vendor at the Kent County 4H Fair. The Advisory Bd is always welcome to attend. Beverly and Catherine have both offered to help with table coverage. Jen will work with them to coordinate with staff.
