## Greetings:

We are very proud of the level of service which the Kent County Sheriff's Office delivered to the citizens of the County during 2010. We are dedicated to maintaining a safe and secure environment for the citizens of Kent County. Statistics alone, however, do not tell the full story of our accomplishments. We have made significant progress in many areas which demonstrate our commitment to our vision:

*The Kent County Sheriff's Office will be a first-class law enforcement agency, delivering superior service to the citizens of Kent County.*

1. Law Enforcement Accreditation. In 2003 the Kent County Sheriff's Office became the first Eastern Shore Sheriff's Office -- and only the second Sheriff's Office of its size nationwide -- to achieve accreditation from the Commission on Accreditation for Law Enforcement Agencies (CALEA). Your Sheriff's Office remains in compliance with more than 400 law enforcement "best practices." We now proudly display the CALEA logo on our uniforms and marked vehicles. On August 1, 2009, the Kent County Sheriff's Office was successful in being awarded their third Certificate of Re-Accreditation.
2. School Resource Deputy. We continue to support Kent County Public Schools with our School Resource Deputy, a combination teacher/counselor/law enforcement officer who works at Kent County High School.
3. Narcotics Enforcement Team. In September 2002, the Sheriff's Office set up its own Narcotics Unit in order to increase accountability in this important area. In year 2010, the NET team made 33 arrests for possession or distribution of narcotics and seized currency and vehicles.
4. Victim/Witness Services. During the summer of 2006, a Victim/Witness Service Provider position was established utilizing a grant from the Governor's Office of Crime Control and Prevention.

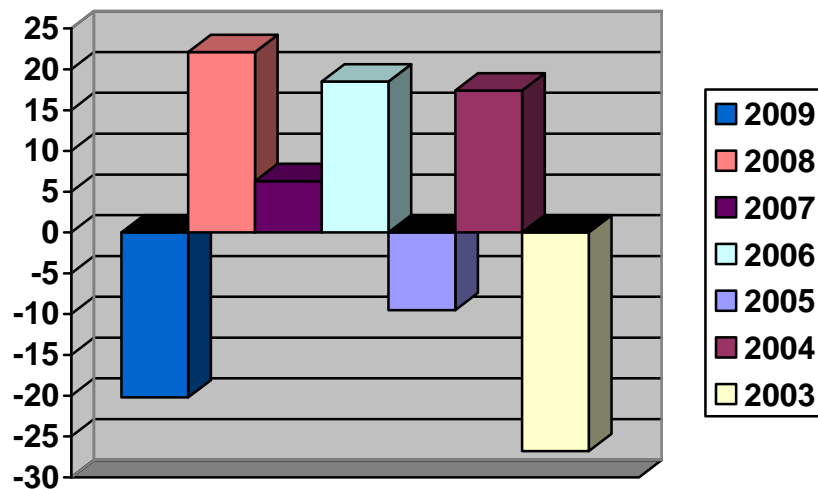
