Ms. Moredock shared a Planning & Zoning update which included:

- The County is reviewing the Comprehensive Water and Sewer Plan update, which includes the upgrades to the Betterton and Galena Wastewater Treatment Plants, Millington annexation and extension of water and sewer services, private sewer services at Bayshore Campground and the Cacaway Family Farm Cooperative.
- The review of a site plan for an expansion of the Gillespie production building at their Brickyard location, to add 17,000+ sq. ft.
- Minor site plan review of a new restaurant being constructed at Haven Harbor South.

Mr. Carrier introduced himself to the Commission.

Johnathan Callahan gave an overview of his plans for the recently purchased Caulk's Field Store property on Rt. 20. Mr. Callahan is working toward opening a deer cutting and processing facility on the site.

Trae Hoffner, student member, presented his capstone project from Washington College titled 'Rural Poverty and Economic Development in Kent County' to the Commission.

Jamie Williams reviewed the proposed amendments to the bylaws and received comments from the Commission Members. Ms. Williams shared that Economic Development with the Local Management Board and Information Technology are working on a housing portal for Kent county. The portal will be a consolidation of housing options and resources throughout Kent County.
