## Introduction

#### WHAT IS OMPP?

## OMPP Survey Data

### STORAGE AND DISPOSAL

- On average, 40% of respondents have seen, known about, or used the medication drop boxes
- 55% of respondents reported utilizing the drop boxes, Take-Back Days or Deterra bags as their preferred disposal method

#### **ACCESS TO TREATMENT**

- About 1 in 5 people seek treatment for themselves
- About 1 in 3 people seek treatment for their loved ones
- Common barriers: Personal issues (ex: not ready to commit, denial)
- Practical, logistical issues (ex: cost, transportation)
- Percieved treatment quality issues

## TALKING WITH A PROVIDER

- 75% of respondents
   either have been or have
   a family member who
   has been prescribed an
   opioid
- Less than 50% of respondents notes that they initiated such conversations about either the risks or alternatives
