HIGHLIGHTS FOR END OF FY2023 ACTIVITIES

RACIAL EQUITY INSTITUTE PHASE 1 WORKSHOP

This year we saw two cohorts participate in the Racial Equity Institute's Phase 1 workshop. This is an extension of several years of anti-racist community building, from 3 Undoing Racism workshops by the People's Institute and Beyond (2016-2019), to over 300 people attending Racial Equity Institute's Groundwater presentation on Martin Luther King Jr. Day in 2020. In FY2022 over 200 Kent County Public School staff members attended the same Groundwater presentation, and this year KCPS partnered with Social Action for Racial Justice and KCLMB for the Phase 1 (2 day) training in May. KCLMB just sponsored a second offering of the Phase 1 workshop with representation from Chestertown Town Council, Kent Family YMCA, the Public Library, Parks & Rec, Sumner Hall, League of Women Voters, Garfield Theater, Mainstreet Chestertown, Rebuilding Together Kent County, Minary's Dream Alliance, KCLMB staff and board, and Washington College.

Immersive learning and community awareness around structural racism is vital for our community building goals. REI and PISAB's workshops are unlike most other Diversity, Equity & Inclusion trainings in that they succinctly transform participants understanding of





how race and racism were created, how they are perpetuated, and how we can begin to take action to address them.
