**COVID 19 Rental Assistance** — MRDC to enroll clients, Mid Shore Pro Bono to attend court and mail those on docket for eviction (needed to address those who do not appear in court, making it very difficult to prevent eviction) Need to present documentation to prevent eviction, Mid Shore Pro Bono can help before its too late.

#### Partner Alerts, Asks & Offers

Doncella Wilson- Minary's Dream Alliance, partnered with WAC for Hip Hop Time Capsule, also launching Teen Clubhouse for youth impacted by substance use – multiple partnerships for skill and youth development. Kent, Caroline, Talbot, Queen Anne's, Dorchester. Working with Shore Rivers on land engineering. Pat Nugent – Hip Hop Time Capsule application closing soon. 8 paid internships for KCHS students to work with WAC students, professors, and KC mentors to explore, create, and record music and poetry.

Michael Harvey: Provost at the college in charge of the academic program and student learning. Washington College loves what Pat, the Heartland Project, and the Starr Center are doing and would like to extend that model to more partnerships, more engagement with the community, and build that more robustly into academic

program. Pursuing that with something half-jokingly called our 'big idea': a possible well-funded initiative in Leadership, Environment, and Community. Maybe that would be the name of a new school, with the financial capacity to support student community service internships. This is in the early stages of what that might mean, but a big part of what it would mean is working with partners like LMB and its members, to get students connected with helping the community at a grass-roots level. If interested you can contact: mharvey2@washcoll.edu, 410-490-4236. This is in the early, brainstorming, speculative phase, so this is the time to bring forth ideas. Van Hamlin, KCPS: 80% of students will start attending school 4 days a week on the 19th.

John Schratwieser – Heartland Artist fellowships, Call for Musicians to partner with KCPS to create curriculum-based class with a fine arts teacher. NEA land research about Native American residents Ozine and Tockwogh tribes, seeking a Native American writer to apply. October 2<sup>nd</sup> Public Event to celebrate the light at the end of the tunnel with artisans, food trucks, partners.

Lauren S. DJS: Just a few referrals and nothing pending in court.

Annie Woodall: In building services on Tues & Thursday every hour on the hour for thirty minutes. Summer Reading Program for all ages with outdoor events. Struggling with Rock Hall branch because the municipal building is still closed to the public. Ashley Boyles: will share other vaccine options in the region. Whitsitt has resumed open-door in-patient treatment on Wednesdays.

Jamie Barrett: Helping KCHD with vaccines with phone calls and referrals. Liz Gross: United Way usually fund 26 to 30 grantees, reviewing applications now for Education, Health, Financial Stability. \$160,000 total grant funds, grants distributed between \$1,000 to \$15,000.

Shelley Heller – The County is in the budget process. American Rescue Plan has been released with about \$10 million total for the County and towns, the County's allocation is \$3.77 million, but will tackle once the budget cycle is winding down. More guidance will come in mid May.

Shelly Neal-Edwards – DSS new system goes live on Monday to determine eligibility for SNAP and TANF. Kinship Navigation support for some cash assistance, the pilot program will help them get guardianship to allow them to be eligible for more benefits, but there is a control group since it's an evidence-based program. START program is running and busy. Agency has several vacancies and a hiring freeze.





Wanda Boyer – Chestertown's 16-month plan includes enslavement memorial that is being guided by Ad Hoc Committee for the Chestertown Memorial of Enslavement. Open to new members.

Sherone, MSBH – Adolescent Clubhouse, Mental Health Crisis Beds at Whitsitt had to be RFP'd out again due to COVID, so now they will be in Talbot starting July 1. Assisted Living Behavioral Health Services RFP starting in Mid May. MSBH is ready to table for outdoor community events and is hiring a finance director.
