MINUTES – The minutes of the January 15 2023, meeting were approved as presented.

## **REPORT FROM THE COUNTY COMMISSIONERS**

### Kent County –Bill Mackey

- 3 projects were approved for funding by the Rural Maryland Economic Development Fund: Millington WWTP, Worton water/sewer extension, and a new entrance to Chestertown business campus off of 301
- Jamie saw a listing in Chesapeake College's brochure for a WWTP training
- Bill Mackey reported that the task force completed putting recommendations together

### **MAYORS' and COUNCIL MEMBERS REPORTS**

### Betterton— Harry Marcy reported:

- Finished paving for tennis courts & Basketball courts, will cure over winter painting will begin soon, pickleball court will also be made
- Moving forward with stone work project on bayside

### **Chestertown – Council Member Herz**

- Actively working on tax differential questions, meetings to being in February 2023, send an email to Tom Herz to be included in these meeting schedules.
- Chestertown's ARPA task force is in their final phase of determining where to spend remaining ARPA funds. Suggestions have been made and awaiting Council approval.
- Bill Ingersol has retired, position is open.
- Strategic plan is posted on Chestertown's website for review. Suggestions welcome.

# Galena – Mayor Carroll

- RFP has been sent out for bike path concept plan, Galena was approved for \$160,000.00 grant
  - 1 RFP received, well below grant amount and indicated engineering could be included in grant amount as well and was approved through MDOT
- Galena is actively working with speed sign company to fix 2 speed signs and reinstall. Also working with the Sheriff to determine best times for police presence.
- Looking for a part time maintenance person
  - Betterton is also looking for a part time maintenance person, it was suggested that if Betterton is still having trouble finding someone, perhaps Galena and Betterton could hire the same person, increasing their hours as desired.
  - Galena shared interest in sharing a maintenance person with Betterton and discussing logistics and future goals for new hire.
- Had some sewer issues pop up around town and town hall that needed repair.
- Dogwood Festival will be upcoming

# Rock Hall – Town Manager Resele

- Planning and Zoning still working on Comprehensive Plan
- Improvements being made at the beach including a boardwalk, chairs, benches, picnic tables and grills
- Submitted an application for 3 pump station replacements for approx.. 2.6 million dollars
- 1.6 miles of sewer main that may need replacement, looking for funding
- ENR (Enhanced Nutrient Reduction) project going well, looking to begin upgrade soon.
- Conversation meeting scheduled for February 26<sup>th</sup> which is a open house type meeting for residents to update them on the repairs and expenses of water and sewer lines.

# MML Updates – MML President Elect John Carroll

- Mayors Conference upcoming
- In the process of purchasing a headquarters for MML in downtown Annapolis
- President retreat will be planned and will need assistance with housing ideas in and around Galena.
- June Conference classes are being planned, a preview of classes will be available in March or April
- Current legislative session going on
  - Looking to increase HUR funding

  - Working to create police accountability boards at the town level for where applicable.
