IMPORTANT: If you are a <u>contract purchaser</u>, the permit cannot be issued until the property transfers.

- If the property owner(s) listed on this application does not correspond with the current Maryland Tax Assessment Records, a copy of the recorded deed will need to be submitted with the application.
- If you <u>plan to purchase</u> the property and fill out the application in your name, you will need a signed letter from the current owner authorizing you to submit the application. A copy of the contract is also sufficient to process a permit.
- If you are a <u>contractor submitting an application for the owner</u>, you will need a signed letter from the owner authorizing you to submit the application.
- If the <u>property is owned by a Corporation, LLC, or Partnership,</u> then you will need to provide documentation on who is authorized to sign on behalf of the Corporation, LLC, or Partnership.

Construction Plans: Two (2) sets of construction plans – hard copies for Accessory Building, Decks/ Porches/Ramps, New Single-Family Dwellings, Swimming Pools, and Solar projects will be required.

Construction Plans: Three (3) sets of construction plans – hard copies for an <u>Addition or Renovation</u> – projects including adding or replacing windows and exterior doors will be required.

What Building Codes are used? Effective May 29, 2023, these codes must be listed on the construction plans with a ResCheck Report. This report determines if the building design meets the requirements of the code.

CONTRACTOR/BUILDER:

✓ A homeowner can be listed as the builder of the project for his/her own house, or the property owner may list themselves as <u>OWNER</u> under Builder. The property owner will be responsible for the builder/contractor they choose. This excludes Mortgage Companies.

<u>Note:</u> If the property owner acts as the builder/contractor, an Affirmation of Landowner as home builder/contractor form is required.

- ✓ For electrical work, the electrician <u>must be licensed through the State of Maryland</u> and <u>must be registered</u> as a master electrician with Kent County Government Maryland. - ✓ For plumbing work, a homeowner may not do his/her own plumbing work in his/her own home. The plumber <u>must be licensed through the State of Maryland</u> and <u>must be registered</u> as a master plumber with Kent County Government- Maryland.
