Dear Kent County Planning Commission Chair and Members:

This letter is to affirm my opposition to the 10% rule in the Agriculture Zoning District. Agricultural owners and entrepreneurs should be provided the opportunity to sell and purchase smaller ag parcels to increase the number of ag businesses here in Kent County. Many new farmers lack the financial resources to purchase 100 or more acres. Likewise a January 2022 Forbes Article on "Trends in Agriculture" highlights a growing demand for more localized and specialized niche farming. Restricting subdivision of ag land via the 10% rule concentrates ag land into fewer large land holding property owners and discourages new ag businesses. I encourage the Planning Commission and the Kent County Commissioners to eliminate the 10% rule in AZD.

I also oppose the proposed forest conservation text amendment to require additional land be put into Forest Conservation, beyond the MD State requirement. This requirement will negatively impact and discourage the sale and improvement of the relatively small amount of industrial and commercial land we have available for development in Kent County. Almost 90% of the land in Kent County is in agriculture use and covered in vegetation most of the year. Only about 6% of our land is zoned for commercial or industrial use. Placing the burden of additional land in forest conservation will have a negative financial impact on potential development. I urge the Planning Commission and the Kent County Commissioners to reject the proposed text amendment.

The Eastern Shore Land Conservancy, Maryland's leading private land trust, supports the text amendment on the Forest Conservation Act and appreciates the opportunity to submit the following comments.

According to the Maryland Department of Natural Resources, Kent County is one of the two least-forested counties in Maryland. And according to the Maryland Department of Planning, Kent County is projected to lose an additional 800 acres of forests in the coming years. As the county's land use ordinance states:

"Forest and individual trees greatly contribute to the quality of life in Kent County, the health of the natural ecosystem and the health and welfare of the citizens of Kent County. The county's economic health depends heavily on its natural resources, of which forests are a major component."

Indeed, forests offer many benefits including wildlife habitat, carbon sequestration, water filtration to protect our rivers and the bay, sediment control, and a healthier environment. Considering the environmental impacts and the projected loss of forested land, Eastern Shore Land Conservancy supports this text amendment as it will help prevent further loss of forests in the county.

The FCA text amendment will help the county realize its goals and strategies in its current comprehensive plan. Goal: Conserve Existing Woodlands, Encourage Reforestation, and Promote Proper Forest Management Practices. Strategy: Work cooperatively with Federal, State, and non-profit organizations to achieve an increase in area of forest in the County. To the Planning Commission of Kent County,

ShoreRivers submits this letter **in support of the proposed text amendment to strengthen forest conservation provisions in Kent County's Land Use Ordinances.** ShoreRivers is a regional nonprofit with more than 2000 members. Our mission is to protect and restore Eastern Shore waterways—including the Chester River, Sassafras River, and the Bayside Creeks of Kent County—through science-based advocacy, restoration, and education.

Maryland loses about 3,000 acres of forest every year. Forest clearing leads to poor water quality, fragmentation and loss of wildlife habitat, reduced carbon sequestration, dirty air, increased temperatures, localized flooding, and lower property values. Development is the single largest driver of forest loss in the state. Kent County is one of the least treed counties in the state, meaning that the negative impacts of development on an already under forested landscape are more acute, as are the detriments to local water quality.

Kent County's Comprehensive Plan acknowledges the "rich agricultural, natural, cultural, and human resources [that] provide the basis for the County's superior quality of life. Fertile soils, gentle topography, mild climate, **verdant woodlands**, the Chesapeake Bay with its productive tidal tributaries, wetlands, and marshes create an environment nearly unrivaled. These natural features enrich our economy and our lives." The plan goes on to specifically outline a no net loss strategy for tree preservation (Kent Comp Plan, pg. 76). **The proposed text amendments are aligned with the County's vision, and will help to strengthen protection for the natural features of our county while "embracing sufficient economic opportunities to provide for the economic well-being of [it's] citizens." (Kent Comp Plan, pg. 1)** In short, trees and forest buffers are one of the most positive long-term investments that can be made to improve water quality in the Chesapeake Bay.

Please see below the names and comments of more than 400 members of the Sassafras and Chester watersheds who have signed onto <u>a ShoreRivers Petition</u> voicing support for increased forest protection in the county. Your community members—and ShoreRivers—are in favor of the proposed text amendments, and urge the Planning Commission to adopt a favorable stance.
